At the outset, Dr. Rakesh Kumar, Member Secretary welcomed the Hon'ble Chairman and other members to the 5th meeting of Academic Council of the Institute. Thereafter, with the permission of the Hon'ble Chairman, the agenda items were deliberated upon and the following decisions were taken unanimously:

Item No. 5.1 Confirmation of the proceedings of 4th meeting of Academic Council
Decision: The proceedings of the 4th meetings of Academic Council were confirmed as no comments have been received from any member of Academic Council.

Item No. 5.2 To report action taken on the decisions of the 4th meeting of the Academic Council

Decision: The action taken report was approved by Academic Council with the following amendments:

Item no. 4.9 'Approval of Academic Regulations 2015-16' was deliberated and following modifications was unanimously accepted:

- (1) The condition of minimum 75% attendance in all theory and practical courses will include maximum relaxation of 10% for all kinds of leaves (e.g. on medical ground, for appearing in competitive exams, etc. etc.), However, while awarding marks for attendance, only the actual percentage of attendance must be considered. The maximum relaxation of 10% in attendance is only for clearing the condition of minimum attendance.
- (2) "6-months training" that was renamed as "Semester Training" will have two components:
Component-1: Three months Industrial Training. It will be conducted in Industry.
Component-2: Two months software Training. For this component the student will have the option to undergo it at the Institute or at the Industry. However, the institute will preferably accommodate most of the students at the institute itself.
- (3) Following marks distribution is adopted for the two components of training replacing the earlier proposed plan:

For Component-1: 3-months Industrial Training

- (4) If a student fails in a course, he can either repeat the whole course or can pass that course by re-appearing in the End-Term Examinations.
- (5) The CGPA multiplication factor will be 10.

Item No. 5.3

Reconstitution of Committee for Dealing with UMCs (Unfair Means Cases in End Term Examinations)

Decision:

The item was approved with following modifications:

- (1) As far as possible, the chairman of the UMC committee must be preferred to be a retired judge.
- (2) The 3rd Member of the Committee "An Administrator" is replaced by "Dean Student Welfare" of the institute.

Following is the final structure of the UMC Committee after incorporating above changes:

1. A Retired Judge/Eminent Advocate : Chairman
2. An eminent Academician : Member
3. Dean Student Welfare : Member
4. Registrar/Nominee of IKGPTU* : Member
5. Registrar/Nominee of MRSSTU : Member

Further, with regard to DMC cases it is decided that the latest rules of IKGPTU will be followed. PTU Nominee, Er. Reetipal Singh will provide the copy of latest UMC rules of IKGPTU, Jalandhar.

Item No. 5.4

Remuneration for the Members of UMC committee

Decision:

The item was approved as proposed with the following additions:

- (1) TA/DA to outside members will be paid as per MRSSTU rules.
- (2) No remuneration and TA/DA will be paid to the Invited Subject Experts as they are the internal faculty of the institute. However, if internal faculty is on official duty outside the institute, then he/she will be paid TA/DA as per MRSSTU rules.

 - d) Mapping of Course Contents with Course Outcomes
 - e) Recommended books
