






At the outset, Dr. Teject Singh, Member Secretary welcomed the Hon'ble Chairman and other members to the 11thmeeting of Academic Council of the Institute. Thereafter, with the permission of the Hon'ble Chairman, the agenda items were deliberated upon and the following decisions were taken unanimously:

Item No. 11.1 Confirmation of the proceedings of 10th meeting of Academic Council

Decision: The proceedings of the 10th meetings of Academic Council were confirmed as no comments have been received from any member of

Academic Council.

Item No. 11.2 To report action taken on the decisions of the 10th meeting of the

Academic Council.

Decision: The action taken report was approved by Academic Councilas proposed.

Item No. 11.3 Regarding the implementation of grading system of IKGPTU

Jalandhar on 2018 batch and onwards.

Decision: Item was approved and it was decided to implement the IKGPTU absolute grading system for 2018 batch onwards. Further, after discussing the matter at length the following decisions have been taken:

1. In view of the practices being followed by IKGPTU Jalandhar,


- a. The IKGPTU regulations 2004 (applicable to 2004 batch onwards) will be applicable for 2018 batch onwards. The total marks obtained in a given subject (including the mid semester and end semester evaluation) will be converted to letter grade by using the equivalence table available for absolute grading system in Choice Based Credit System of the IKGPTU Jalandhar issued in 2016.
- b. A candidate has to score 40% in mid semester and 40% in the end semester evaluation separately to pass a subject. The candidate will earn grade F in case he/she fails in mid semester evaluation and/ or end semester examination.
- c. The candidate is allowed to appear for reappear in the mid semester evaluation and/or end semester evaluation depending on failure of the candidate in mid semester evaluation and/ or end semester examination respectively.
- 2. As per the breakup of assessment and examination in the IKGPTU system, the courses are divided into theory and practical subjects. In case of Bachelor in Architecture the practical subjects should be substituted with studio based subjects if applicable.
- Additionally, any other condition/modification applied by IKGPTU
 Jalandhar in its absolute grading system shall be applicable to the
 students of 2018 Batch onwards.
- Item No. 11.4 Regarding the moderation of mid semester/end semester examination marks for first semester of 2018 batch students in

consequence of the implementation of grading system of IKGPTU Jalandhar.

Decision:



Item was approved as proposed. However, for the moderation of mid semester evaluation the faculty must ensure that the average marks obtained by the students of the class should be within 65% to 75% and all students obtaining atleast 25% marks may be upgraded if required. This moderation of mid semester evaluation shall be applicable for 2018 Batch onwards.

In case of moderation of end semester examinations (November 2018) for first semester of 2018 batch the scale of moderation should be as follows

- (i) All the students scoring equal to or more than 25% marks have to be upgraded.
- (ii) The level of upgradation should be such that the student scoring the minimum marks as per condition (i) scores 40%. In a given subject, the marks obtained (considering students scoring 25% marks) and the moderation required are as follows:

- (iii) After moderation it must be ensured that the topper before moderation should still remain the topper after moderation.
- (iv) Further, the moderated marks should not exceed the maximum marks.

*For example, if in a subject, considering the student scoring at least 25% marks, the marks obtained are 15,16,18,19,20,......50,51,53,54,56; then the upgradation is to be done by 9 marks for all of them subject to the other conditions





mentioned. The upgraded marks shall be 24,25,27,28,29,.....59,59,59,59,60 respectively.

**If the marks obtained are 16,18,19,20,.....50,51,52,53,54,56 (no one has scored 15 marks); then the upgradation is to be done by 8 marks for all of them subject to the other conditions mentioned. The upgraded marks shall be 24,25,27,28,.....,58,59,59,59,59,60 respectively.

If the marks obtained are 16,18,19,20,.....47,48,49,50 (no one has scored 15 marks); then the upgradation is to be done by 8 marks for all of them subject to the other conditions mentioned. The upgraded marks shall be 24,25,27,28,....., 55, 56, 57,58respectively.

Item No. 11.5 Regarding change in question paper pattern.

Decision: The council reviewed the decision taken in Board of Studies of

Mechanical Engg Department for the subject Machine Drawing (BTME303A/BTME303) and it was decided to increase the duration of the end semester examination to 4hours from 3hours. The question paper shall consist of 10 questions of 2 marks each in Part A. Part B will consist of two questions carrying 15 marks and 25 marks with internal

choice. The questions in Part B may be subdivided if desired.

Item No. 11.6 Ratification of change in examination process for B Arch end

semester examinations.

Decision: Item was approved as proposed.

Item No. 11.7 Revision of rates of remuneration for various examination related

activities in consequence of revision of rates by IKGPTU Jalandhar.

Decision: Item was approved as proposed.

Item No. 11.8 Constitution of Department Research Committees (DRCs) for

various Departments of SBSSTC, Ferozepur.

Decision: Item was ratified as proposed. However, the necessary amendments

should be done so that UGC guidelines are followed.

At the end of meeting it was also decided that the name of students should be struck off from college rolls if the student remains absent continuously for 45 days in all the classes, labsand tutorials in place of 15 days decided earlier in 10th academic council meeting(Item no. 10.6).

The meeting ended with a vote of thanks to the Chair.
