**Item No.32.06      Implementation of Chief Minister Scholarship Scheme (CMSS) on new courses i.e. PGDCA and BSc Agriculture alongwith LEET students of all courses.**

In the 28<sup>th</sup> meeting of BOG vide agenda item no 28.3, it was decided that CMSS shall be applicable, as per govt. policy, on all students of Diploma, B.Tech., B.Arch, BCA, MCA and M.Tech to be admitted in the 1st year of session 2017-18. Thereafter, in the 31<sup>st</sup> meeting of BOG vide agenda item no. 31.04, the board has again decided to implement CMSS for the academic session 2018-19 on the same terms and conditions as already approved in the 28<sup>th</sup> meeting of BOG.

After this now the institute has started two new courses PGDCA and BSc Agriculture. In the meeting of all the HOD's held in the institute on 30/5/2018, it was decided to implement CMSS on the students to be admitted in PGDCA and BSc Agriculture along with students admitted under LEET (2<sup>nd</sup> Year) in all the branches.

Therefore, it is proposed that CMSS should also be implemented on the students to be admitted in PGDCA and BSc Agriculture along with students to be admitted under LEET (2<sup>nd</sup> Year) in all the branches.

**Item No.32.07      Permission for attending regular classes of Ph.D courses alongwith their routine duties in the Institute for internal faculty/staff.**

In the 9<sup>th</sup> meeting of Academic Council held on 7/2/18 vide agenda item no. 9.5, it was decided to start the Ph.D programme in all the disciplines. In the meeting of all the HOD's held in the institute on 30/5/2018, it was decided that the internal candidates (i.e Regular and contractual employees working in the institute) may be allowed to attend the regular Ph.D classes for completing their course work requirement of six months for Ph.D., along with the teaching load and other duties assigned to them.
