#### Item No. 4.3 Providing quality education in theory and practical classes

- (iv) All HODs must also ensure the use of audio-visual aids to make the theory classes more interactive, instructive and revealing.

Item No. 4.8 Ratification of Minutes of meetings of Department Quality

CSE departments held in the month of June, 2017 were ratified as

#### Item No. 5.3 Affiliation with IKGPTU, Jalandhar-regarding

Initially Shaheed Bhagat Singh State Technical Campus, Ferozepur, was affiliated with IKGPTU, Jalandhar. However, after the formation of Maharaja Ranjit Singh State Technical University (MRSSTU), Bathinda in the year 2015, the affiliation of Shaheed Bhagat Singh State Technical Campus, Ferozepur was shifted to MRSSTU Bathinda. Consequently, students of SBSSTC, Ferozepur and other colleges opposed this decision of Punjab govt. and sought affiliation with IKGPTU, Jalandhar. Subsequently, Punjab Govt. has changed the name of MRSSTU, Bathinda as Maharaja Ranjit Singh Punjab Technical University, Bathinda.

In the month of November-2018, Punjab Govt has changed the act of University and all affiliated colleges of MRSPTU, Bathinda have given the one time choice, if they want to shift their affiliation from MRSPTU, Bathinda to IKGPTU, Jalandhar. Subsequently, based on the memo No. 108-109 dated 22.01.2018 issued by the office of Director Technical Education and Industrial Training, Punjab, the IKGPTU, Jalandhar has issued a letter No IKGPTU/Reg/4121 dated 25.01.2018 vide which it sought the consent of colleges if they want affiliation of IKGPTU Jalandhar (Annexure—II, page no.15-16).

Consequently, a meeting of Institute Development Committee of SBSSTC consisting of Director, Associate Directors, all HODs, all Deans, Principal Poly Wing and Registrar was held on 23.01.2018 to discuss the issue of affiliation of Shaheed Bhagat Singh State Technical Campus, Ferozepur. In this meeting, it was unanimously decided that SBSSTC Ferozepur must give its choice of affiliation with IKGPTU Jalandhar (Annexure—III, page no.17). Association of non-teaching employees also demanded that SBSSTC, Ferozepur must give its choice for affiliation with IKGPTU, Jalandhar (Annexure-IV, page no.18).

Here it is worth to inform here that IKGPTU, Jalandhar has approved the Autonomous Status of SBSSTC, Ferozepur vide letter No IKGPTU/Reg/10075 dated 19.08.2015 (Annexure—V, Page no.19), But MRSPTU, Bathinda till date didn't approve it.

Based on the decision of HODs/Deans Meeting and demand of association, it is proposed that Shaheed Bhagat Singh State Technical Campus Ferozepur should apply to IKGPTU, Jalandhar for getting affiliation from IKGPTU.

The above said proposal is placed before the IQAC for consideration and approval.

# Item No. 5.4 Adoption of syllabus proposed by AICTE for colleges w.e.f 2018 – regarding.

AICTE has prepared the syllabus of all the courses for the students to be admitted in the year 2018. It is proposed that the institute may also implement the syllabus prepared by the AICTE for 2018 batch onwards. Since our institute is having academic autonomy, therefore, if the department wants some modifications in the syllabus due to some local conditions then they can implement that with the approval from the Board of Studies (BoS) of their department, subsequently, duly approved by academic council.

The matter is placed before the IQAC for consideration and approval.

# Item 5.5 Regarding the submission of five self imposed objectives by the staff members.

It is proposed that all the staff members must submit five self imposed objectives for the betterment of efficiency and effectiveness of the institute. There must be some self regulation for all the employees to know their performance, therefore, it is proposed that every employee must set 5 objectives at his/her own level for the financial year 2018-19, which can be included in the ACR for self appraisal. The objective should be as per the following format for the teachers.

- 1. Result of the students
- 2. Evaluation in time
- 3. Percentage of class engagement.

The above 3 objective should be quantitative and the staff can select other two objectives as qualitative.

Similarly, the non teaching employees should also have 3 quantitative and two qualitative objectives which have to be reviewed by the respective HOD/ Section in charges of their departments.

The matter is placed before the IQAC for consideration and approval.
