- 4. Total proposed budget for non-recurring expenditure of Development Funds has been reduced from Rs. 181 Lacs to Rs. 110.79 Lacs. However, Campus Director is allowed to adjust the expenditure under its different headings, if any, within the limits of total approved budget of Rs. 110.79 Lacs.
