Sir,

This is regarding Compliance Reports submitted by Shaheed Bhagat Singh State Technical Campus, Moga Road, Ferozepur-152004, Punjab for the UG Engineering program in whose case the First Cycle of accreditation of 6 years in Tier II has expired on 30.06.2020.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II first for a period of 3 years upto 30/06/2017 and were further accredited for a period of 3 years upto 30/06/2020 on the basis of Compliance Reports and whose applications for accreditation beyond 30/06/2020 are pending due to the current situation arising out of the pandemic caused by the Corona virus, the programs will be considered for accreditation of one year after expiry of the validity of accreditation on 30-06-2020 on the basis of Compliance Reports. The data submitted by Shaheed Bhagat Singh State Technical Campus, Moga Road, Ferozepur-152004, Punjab in the Compliance Reports have been examined and verified in NBA. 
