### Item No 36.03: Approval of proposal to Increase the revenue of the Institute.

In the 35<sup>th</sup> meeting of Finance Committee of SBSSTC Ferozepur held on 26/6/2018 under the Chairmanship of Secretary Technical Education and Industrial Training, Punjab regarding the approval of budget for FY 2018-19, it was decided to put up the budget on a single file to the office of DTE/IT along with suggestions to improve the Admission and Financial Position of the Institute. Accordingly, the following proposal is submitted for increasing the Income and admission in the Institute:

#### 1. Starting of new courses:

- a. The Institute has started two new courses i.e B Sc (Agriculture) & PGDCA with intake of 30 each from this session w.e.f July 2018.
- b. The Institute is planning to start some more new courses which are in high demand like Diploma in Civil Engg and B com (Professional). In this regard, a committee has been constituted to look into the various aspect of starting the new courses (Annexure VI, Page 38).

#### 2. Construction of Shops along the boundary of the Institute:

The Institute is situated on National Highway and have a large front face. It is planned to construct some buildings along the boundary wall on the front side, so that they can be given on rent for various activities like Bank, ATM, Eating Joint, Furniture showroom, Garment Shop etc. A detailed plan will be put up for approval in the next meeting of Building & Works Committee of the Institute to be chaired by the Secretary Technical Education & Ind Training Punjab.

### 3. Efforts to fill the existing seats:

The Institute is making all round efforts to increase the admission in various courses as per below:

- a. We have put hoarding in all the nearby cities of Ferozepur, Faridkot, Moga and Fazlika (AnnexureVII, Page 39).
- b. A meeting of HOD was held in which it was decided to form local area committees of various employees vide office order no 3321 dated 9/03/2018 to visit the various Schools and villages so as to create awareness among the students for joining diploma/B.TechProgrammes(Annexure VIII, Page 40).

- c. The teams of faculty/Staff has been deputed vide order no 968.dated 18/6/18 to visit various states like UP, Bihar, Jharkhand, Himachal etc so as to attract the students from these states(Annexure IX page 41).
- d. All employees of the institute has been assigned the responsibility of admitting at least 04 students to different courses filing which their annual increments will be withheld (AnnexureX, Page 42).
- 4. The college is having a large campus of approximately 100 acres. It is planned to put up a Fruit orchid on the vacant available land so as to increase the revenue.
- 5. The Institute is giving high priority to Placement activities so that the students can get the employment which will leads to higher admission in the Institute.
- 6. It is also mentioned here that there are 190 sanctioned post of Faculty in Engg wing and 54 posts in Diploma Wing. Out of these post, only 35% posts are filled in Engg Wing and 25% in Poly Wing on regular basis. The remaining posts are filled as Guest Faculty on consolidated salary of Rs 15000 per month only so as to reduce the expenditure.
- 7. In addition to all the above steps, Institute is trying to reduce the Expenditure by putting restrictions on TA/DA entitlement, Use of Air Conditioners etc.

The matter is put up before the Finance committee for consideration and approval please.
