**ITEM NO 4.2 To report action taken on the decision in the 3<sup>rd</sup> meeting of equipment store purchase committee meeting held on May 18, 1998.**

**Item No. 3.1 Fabrication of Bus Body on TATA CHASIS LP 1510/52**

**Decision:** Committee considered the proposal & allowed with suggestion that firm may be approached to work at the rates offered to Director State Tpt. Pb. Chandigarh vide letter no. 318-60/TAI dated 14-01-97 against their tender.
